| General Summary | The intermediate bridge inspection crew member performs general/visual and in-depth inspection of bridges. Responsibilities are performed under moderate supervision. |

Examples of Work

- (1) Operates under-bridge inspection and related equipment to visually examine bridges for cracks, fractures, and deterioration.
- (2) Assists preparing reports and other documentation related to general and in-depth inspection of bridges; performs NDT to identify structural deficiencies undetectable through visual inspections.

- (3) Sets up traffic control devices such as signs, flags, cones, and arrow boards; performs flagging responsibilities for traffic through work zones.
- (4) Conducts equipment safety checks; performs preventative maintenance on vehicles and equipment including monitoring fluids, greasing and oiling parts, cleaning, and making minor repairs, as needed.
- (5) Assists in organizing supplies, materials, equipment, and tools in preparation of assigned work; assists in the documentation and recording of equipment and materials usage.
- (6) Operates vehicles to transport crew, equipment, and materials to job site.
- (7) May assist routine maintenance crews with snow removal activities, including plowing snow and spreading ice control materials.
- (8) Performs other responsibilities as required or assigned.
