MINUTES OF THE HIGHWAYS AND TRANSPORTATION COMMISSION SPECIAL MEETING HELD IN JEFFERSON CITY, MISSOURI, WEDNESDAY, MAY 18, 2022

MODOT PRESENTATIONS

2023-2027 DRAFT STATEWIDE TRANSPORTATION IMPROVEMENT PROGRAM (STIP)

On behalf of the Director, Eric Curtit, Transportation Planning Director, presented the 2023-2027 Draft Statewide Transportation Improvement Program (STIP) which is developed in unison with the budget and financial forecast. Mr. Curtit explained the STIP is MoDOT's proposed list of transportation projects for the next five years. This document describes how transportation dollars are being invested, and represents MoDOT's commitment to Missourians.

Mr. Curtit explained the 2023-2027 draft STIP was discussed at the May 4, 2022 Commission meeting. With the legislature still in session during that meeting, pending legislation could have impacted the amount of funding available for the draft STIP. In an abundance of caution, the department chose to wait to publish the draft STIP until the legislative session was completed.

The next step in the process is for the department to conduct a public comment period for the draft STIP, from May 18, 2022 through June 17, 2022. The draft STIP will be shared with various audiences by personal contacts, news releases, MoDOT's website, and available at MoDOT buildings across the state. The department will collect the comments received and recommend action, noting any changes to the draft STIP. The final STIP will then be presented to the Commission at its July 6, 2022, meeting for consideration and approval. The Commission commended Mr. Curtit and his staff on the preparation of the STIP and coordinating with the public. It was also noted the approval of the STIP is one of the most important things the Commission does because it demonstrates our commitment to Missouri taxpayers. It is an important document because it tells precisely how transportation dollars are being invested.
