## **Examples of Work**

- (1) Coordinates the department's safety and occupational health programs.
- (2) Identifies and assesses risks, exposures, and hazards through development and management of control strategies for department operations.
- (3) Measures, evaluates, audits, and continually improves the effectiveness of hazard control programs.
- (4) Conducts safety training, performs ergonomic assessments, and organizes industrial hygiene testing; may coordinate workplace security programs, including training.
- (5) Conducts or directs investigations of workplace incidents involving department employees to determine cause and make preventative recommendations; may assess and review workplace locations for security risks.
- (6) Investigates workers' compensation, fleet vehicle liability, general liability, and property damage claims.
- (7) Compiles injury and vehicle accident statistics used to identify accident trends and develop prevention

programs.

- (8) Conducts worksite audits of facilities, operations, and work activities; makes recommendations to minimize hazards and/or exposures and improve workplace security.
- (9) Coordinates the activities of various safety committees.
- (10) May assist district management in implementing and coordinating department processes involving employee occupational safety programs and workplace security.
- (11) May assist in environmental compliance programs per applicable federal, state, and local laws.
- (12) Performs lead worker responsibilities, which may include providing general instruction, assigning and reviewing work, coaching and training, providing guidance and instruction in the proper and most efficient methods of accomplishing tasks, and providing input to the direct supervisor on staffing decisions and performance management.
- (13) Performs other responsibilities as required or assigned.
